

Nutritional Assistance Program (PAN)

- ❖ Fill out the service request. This form already has an area where the parent home educator self-certifies the child's education. So just fill in that part and leave the area directed to regular school blank.
- ❖ When renewing the PAN application, the agent may require proof of home education. This need could be satisfied simply in the course of the interview with you. If not, then they may ask for additional evidence.
- ❖ Membership in support groups and organizations is NOT mandatory, but voluntary. Therefore, applying for a letter of affiliation to grant benefits cannot be required.

Any of the following must be sufficient:

- sample of the child's work or list of resources used
- letter from your local support group, if applicable
- Charter of the person providing home education

The ADSEF/PAN division understands that there is still ignorance about this policy at local level and are interested in eliminating these difficulties with our community when they arise. NAP Eligibility Rules Regulations

- ❖ B. The minor may:
 1. Be enrolled in a traditional teaching school,
 2. Receive education under the system of "home school" ("homeschooling"),
 3. Be enrolled in a free study program to complete the higher school.
- ❖ C. This requirement will not apply to legally emancipated minors or minors who have completed higher education.
- ❖ D. The person in charge of the service core, his/her spouse or authorized representative (a) must submit with the application, recertification, and changes to include a child under five (5) years old at any time (17):
 1. Registration certificate
 2. Certification signed by the school, institution or school tutor (a) on participation in the Home School System (Homeschooling) or,
 3. Certification of the free study program to complete twelfth grade (Grade Twelve)
 4. Any other official document certifying the name of the school, grade or its equivalent, which the minor is attending and who the person(s) in charge are.
 5. In the case of Home-School System ("Homeschooling") it may also be verified, by certification from the support group, if applicable, or certification from the person providing home education.
